In pursuance of the communication cited under reference, it has been viewed seriously by the HQrs. Office vide D.O. letter No. AT/II/2701/7<sup>th</sup> CPC/Report-III dated 12/06/2018 that around 9078 arrear claims on account of implementation of 7<sup>th</sup> CPC orders are still pending understandably due to non submission of claims by the units concerned.


In this connection it is intimated that consequent upon implementation of CCS (RP) Rules 2016, Pay fixation of 9078 officers of Ordnance Factories and allied establishments have been done centrally by Pay(O) section of PCA(Fys), Kolkata and arrears payments are being made by Br AOs concerned and subsequently forward the paid bills to Pay(O) Section of this office for necessary post audit.

It is, therefore, requested that units concerned may be pursued for immediate submission of claims in respect of remaining cases.

In view of the above, an expeditious action towards completion of arrears payment in respect of the above officers on account of implementation of 7<sup>th</sup> CPC orders may please be ensured. A unit wise report in this regard may please be forwarded to this office on an urgent basis so as to furnish the updated position to the HQrs. Office immediately.
