Applications may be preferred as per enclosed proforma after fulfilling the conditions laid down in Rule 19 of the SAS Rules and forwarded to this office by 07.07.2017 by fastest means of communication so that this office may be able to rendered the request for revaluation to HQrs office within the 45 days of issue of HQrs letter No. AN/SAS/16100/SAS-I/May/2017/Result dated 01.06.2017.

5. While forwarding the requests for revaluation, it may be ensured that the candidates concerned have secured 30% of marks in the Paper(s) for which they desire revaluation.

6. As the SAS Part II Examination is schedule to be held in September, 2017, the time schedule for submission of applications for Revaluation may be strictly adhered to. It is therefore, enjoined upon all the CsFA (Fys) that applications of candidates which are not preferred within the prescribed time period and do not fulfill the requisite condition for revaluation, may not be entertained/forwarded to this office.

As the dispatch /receipt of this circular may take some time, **it is impressed upon all concerned that for adherence to the time frame of the SAS Part-II examination, necessary action may be taken immediately based on uploading of this Part II Office Order on this office website without waiting for copy by post.**
